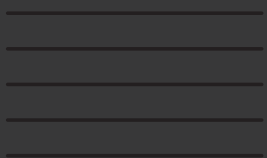

# Main Objectives and Purpose of the Projekt

The main objective of Swissance Capital is to offer **small and medium-sized investors** an opportunity to benefit from strategies and advantages that are otherwise only accessible to large institutional investors (e.g. venture capital firms). At the same time, the buyback and burn mechanism aims to achieve long-term growth of the token while efficiently investing the capital in high-yield crypto projects.

## Why is this coin unique?

Swissance Capital differs from traditional investment funds through its unique model:

- First **investment club in the crypto sector** to offer small investors access to exclusive projects.
- Possibility of indirect participation in crypto start-ups by simply holding the **SWISS token**.
- **Buyback-and-burn-mechanism** to reduce volatility and strengthen the token in the long term.
- No direct focus on large investors ("whales"), but rather **community-driven value growth**


# Introduction

## Background of the Project



The crypto industry is one of the fastest growing financial sectors in the world. Despite this growth, access to highly profitable investment opportunities is often reserved for institutional investors. Swissance Capital aims to change this by creating a **fair and sustainable investment structure** for all market participants.





# Which Problem is solved with this Coin?

In the current crypto landscape, it is mainly **venture capital firms (VCs)** that benefit from new projects and token sales, while smaller investors often do not have access to these early investment opportunities. This leads to an inequality where institutional players reap huge profits while small investors are faced with volatile markets and risky speculation.

Swissance Capital creates a **long-term, sustainable investment strategy** for holders of the **SWISS token** by providing stable returns through strategic partnerships **and diversified investments** in the crypto market.

## Target Group

Swissance Capital is aimed in particular at:

- **Small investors** who want to benefit from professional investment strategies.
- **Strategic partners** who would like to realise innovative projects together with Swissance Capital.
- **Community members** who want to be part of a strong, long-term orientated investment group.

## Current Market Situation and Trends

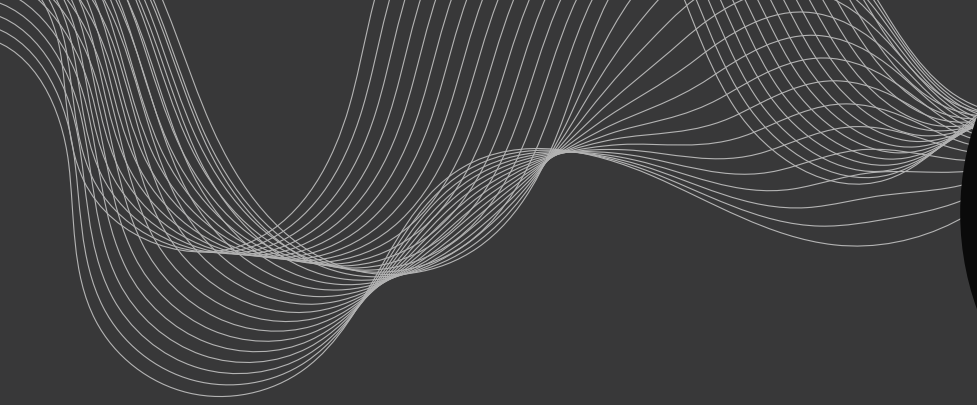
- **Tokenisation of real assets (RWA):** More and more companies are turning to the tokenisation of real estate, commodities and company shares.
- **Decentralised finance (DeFi):** Protocols for lending, staking and yield farming offer attractive returns.
- **Artificial intelligence (AI) in the blockchain:** New AI-supported investment strategies are revolutionising the market
- **Increasing regulatory acceptance:** More and more countries are developing clear regulatory frameworks for cryptocurrencies, which is attracting institutional capital



## Competitor Analysis and Advantages of Swissance Capital

Most existing crypto investment funds are aimed exclusively at institutional investors or require high entry barriers. Swissance Capital, on the other hand, offers:

- **Easy participation with the SWISS token.**
- **Diversification through various investment strategies.**
- **Long-term growth through buyback and burn.**

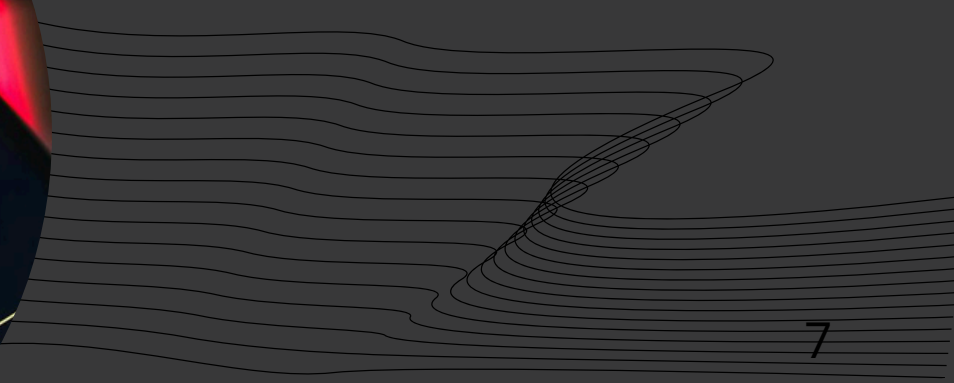


# Technical Specifications

- **Blockchain:** Binance Smart Chain (BSC)
- **Token standard:** BEP-20
- **Consensus mechanism:** buyback and burn to minimise speculation and enable long-term growth.
- **Smart Contract Details:** Will be published on the official channels of Swissance Capital.

## Good to know:

In the buyback-and-burn mechanism, SWISS tokens are bought back from the market and permanently destroyed. This leads to a gradual shortage of the total supply and can potentially contribute to a long-term increase in the value of the token. This method also returns a portion of the profits generated from investments directly to the community in the form of services and exclusive rewards





# Tokenomics

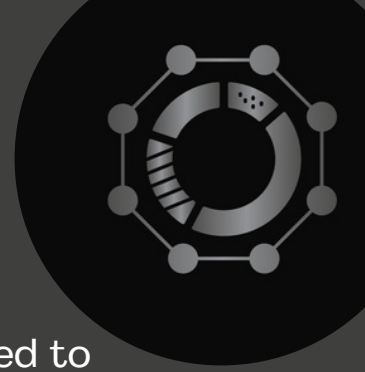


**Swissance Capital's (SWISS) Tokenomic** has been designed to ensure long-term stability, sustainable growth and a fair distribution of resources.

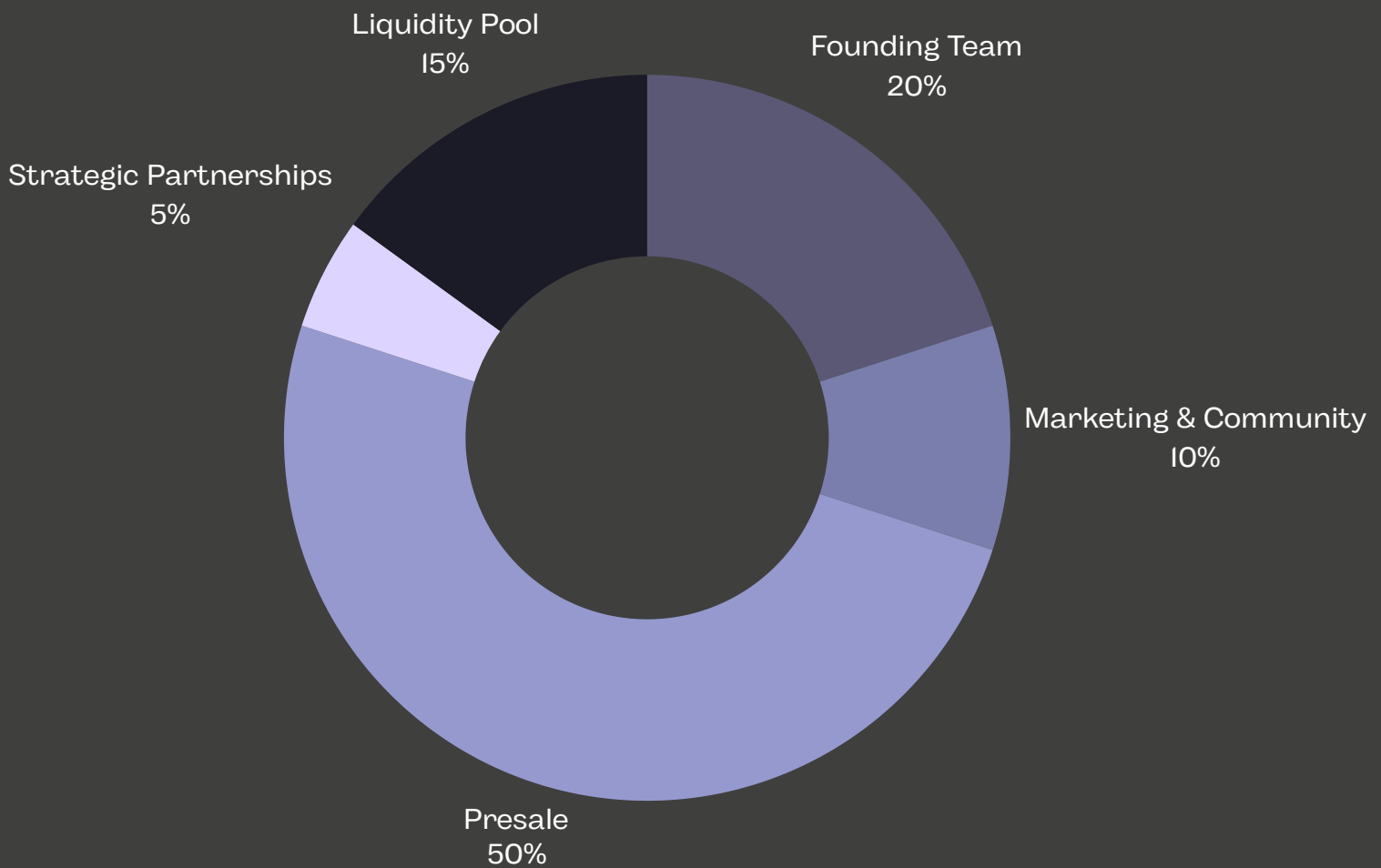

# Token Allocation

The distribution of the overall offer was carefully planned to ensure a balance between investors, the community, strategic partners and the long-term development of the project.



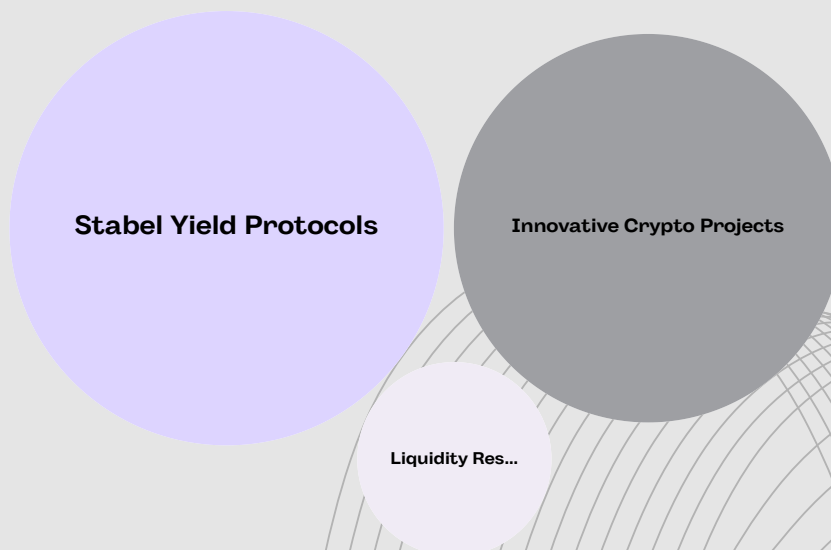
The **founding team** commits to a long-term commitment to the project by keeping 20% of the tokens locked up for three years. This emphasises the long-term vision and commitment to sustainable success.



# Utilisation of Capital

Swissance Capital strategically invests the capital raised in various sectors of the crypto market.

- **50 %** - Long-term investments in stable yield protocols (e.g. DeFi, staking)
- **40 %** - Investments in innovative crypto projects with high growth potential
- **10 %** - Liquidity reserve for stabilisation and hedging



This diversification means that the capital is used for both **stable earnings and strategic growth investments**.

Investment projects are selected on the basis of a multi-stage review process. Criteria such as market potential, team experience, technological innovation and regulatory compliance are taken into account. Swissance Capital also analyses the long-term economic viability of the projects to ensure stable earnings and sustainable growth.

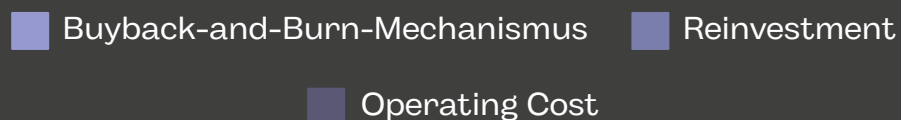
# Profit Distribution



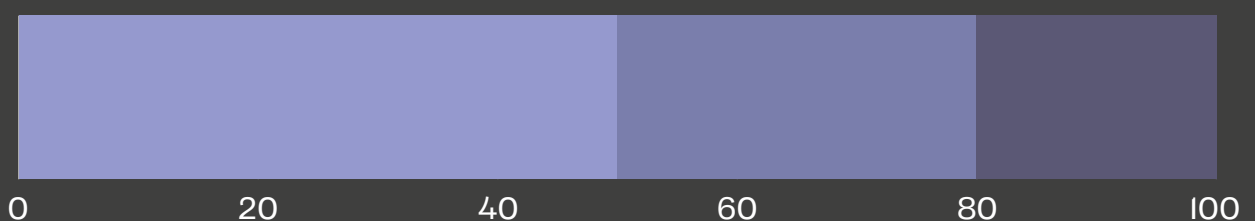
The income generated by strategic investments, DeFi protocols and other yield models is utilised according to the following structure:

- **50 %** of earnings - **buyback-and-burn-mechanism** for long-term token development
- **30 %** of earnings - **reinvestment to strengthen** the capital base and increase earning power
- **20 %** of earnings - **covering operating costs** (e.g. cyber security, insurance, infrastructure)

The buyback and burn mechanism ensures a gradual shortage of the token supply, which supports the growth of the SWISS token ecosystem.

## Functions of the token

- **Community involvement:** The Swissance Capital community can make suggestions about future investment strategies and partnerships.

This ensures that the strategic direction of the project is driven by the interests of the community.
- **Passive advantages through the buyback and burn mechanism:** The continuous buyback and burning of tokens strengthens the value of the token in the long term.
- **Reduction of losses due to scam projects:** Token holders can request a research report on any crypto project to protect themselves from any losses caused by scams.

# Security & Compliance



Swissance Capital places the highest value on security and regulatory compliance.

## Safety measures

- **Cyber security:** Implementation of first-class security protocols to defend against hacker attacks.
- **Smart contract audit:** Cooperation with renowned audit companies (e.g. Certik) to guarantee code security.
- **Insurance cover:** Protection against potential losses due to external security threats.

In addition to smart contract audits, Swissance Capital relies on regular external security checks. We work with experienced cyber security experts to identify and rectify potential vulnerabilities at an early stage. In addition, the platform is continuously adapted to regulatory requirements to ensure the long-term security of users and investors.

## Regulatory Strategy

Swissance Capital endeavours to comply with the applicable laws and relies on a **transparent and compliance-friendly structure** in order to take into account the requirements of **FINMA**.

To strengthen regulatory security, Swissance Capital is evaluating the possibility of official registration or licensing in crypto-friendly jurisdictions. The aim is to proactively fulfil the legal framework and offer investors an environment that is as legally secure as possible. In addition, continuous monitoring of regulatory developments is ensured in order to implement any necessary adjustments at an early stage.

- **Regulatory uncertainties:** Changes in legislation could have an impact on the project.

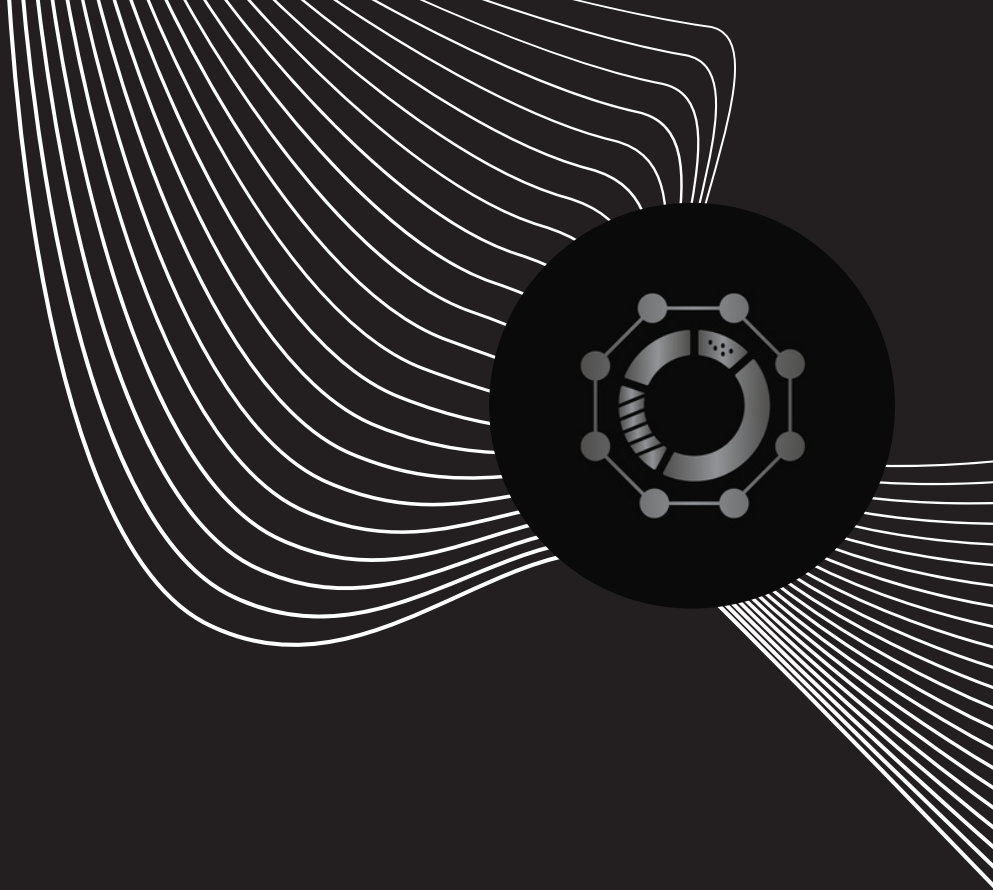
